**1. INTRODUCTION**

The purpose of this circular is to provide you with requisite information regarding resolutions to be proposed at the AGM. The proposed resolutions include (i) re-election of Directors; and (ii) grant of general mandates to issue and to repurchase Shares.

### 2. RE-ELECTION OF DIRECTORS

The Board currently comprises ten Directors, of which four are Executive Directors, namely Mr. LI Chao Wang, Ms. YU Yi Fang, Ms. ZHANG Dong Fang and Mr. DONG Yi Ping; two are Non-Executive Directors, namely Mr. Johann Christoph MICHALSKI and Mr. Ulf Olof Lennart SODERSTROM; and four are Independent Non-Executive Directors, namely Dr. CAO Zhen Lei, Mr. KAM Robert, Mr. HUI Chin Tong, Godfrey and Mr. TSUI King Fai.

In accordance with Article 86(3) of the Articles of Association, any Director appointed by the Board to fill a casual vacancy of the Board shall hold office until the next following general meeting of the Company and shall then be eligible for re-election at that meeting.

In accordance with Article 87(1) of the Articles of Association, at each annual general meeting of the Company, one-third of the Directors for the time being (save and except those Directors in respect of whom the provision of Article 86(3) applies) or, if their number is not three or a multiple of three, then the number nearest but not less than one-third, shall retire from office by rotation. The Directors to retire in every year shall be those who have been longest in office since their last re-election but as between persons who became Directors on the same day, those to retire shall (unless otherwise agree between themselves) be determined by lot. Accordingly, Mr. LI Chao Wang, Mr. DONG Yi Ping, Mr. Johann Christoph MICHALSKI and Mr. HUI Chin Tong, Godfrey will retire by rotation and, being eligible, offer themselves for re-election at the AGM.

The biographical and other details of the Directors proposed to be re-elected at the AGM are set out in Appendix I to this circular.

### 3. GENERAL MANDATES TO ISSUE AND TO REPURCHASE SHARES

It will be proposed at the AGM to grant to the Directors general mandates (i) to allot, issue and deal with Shares up to a limit equal to 20% of the aggregate nominal amount of the share capital of the Company in issue as at the date of passing the relevant resolution and adding to such general mandate so granted to the Directors any Shares representing the aggregate nominal amount of Shares repurchased by the Company under the Repurchase Mandate and (ii) a Repurchase Mandate to purchase Shares not exceeding 10% of the aggregate nominal amount of the share capital of the Company in issue as at the date of passing the relevant resolution.

As at the Latest Practicable Date, a total of 957,440,686 Shares were in issue. Subject to the passing of the proposed resolution granting the Issue Mandate to the Directors and on the basis that no Shares will be issued and/or repurchased by the Company prior to the AGM, the Company would be allowed under the Issue Mandate to issue a maximum of 191,488,137 Shares representing 20% of the aggregate nominal amount of the issued share capital of the Company at the date of the AGM.

The Issue Mandate and the Repurchase Mandate would expire at the earliest of: (a) the conclusion of the next annual general meeting of the Company; or (b) the expiration of the period within which the next annual general meeting of the Company is required by the

Articles of Association or by any applicable laws to be held; or (c) the passing of ordinary resolution(s) by Shareholders in general meeting revoking or varying the authority given to the Directors.

An explanatory statement, as required by the Listing Rules to be given to Shareholders in connection with the Repurchase Mandate, is set out in Appendix II to this circular.

#### **4. ANNUAL GENERAL MEETING**

A notice convening the AGM to be held on Wednesday, 23 May 2012 is set out on pages 13 to 16 of this circular. A form of proxy for use at the AGM is also enclosed with this circular. You are requested to complete the form of proxy and return it to the share registrar of the Company, Computershare Hong Kong Investor Services Limited, in accordance with the instructions printed thereon not less than 48 hours before the time appointed for holding the AGM or any adjournment thereof, whether or not you intend to be present at the AGM. Completion and return of the form of proxy will not prevent you from attending and voting in person at the AGM or any adjournment thereof should you so wish.

#### **5. VOTING BY POLL**

Pursuant to Rule 13.39(4) of the Listing Rules, any vote of shareholders at a general meeting must be taken by poll. Therefore, all the resolutions put to the vote at the AGM will be taken by way of poll. The chairman of the AGM will explain the detailed procedures for conducting a poll at the commencement of the AGM.

After the conclusion of the AGM, the poll results will be published on the website of the Stock Exchange and the website of the Company.

#### **6. RECOMMENDATION**

The Board is of the opinion that the re-election of Directors and the granting of general mandates to Directors to issue and repurchase Shares are in the best interests of the Company and the Shareholders. Accordingly, the Directors recommend the Shareholders to vote in favour of all the relevant resolutions to be proposed at the AGM.

The biographical and other details of the Directors proposed to be re-elected at the AGM are set out as follows:

**Mr. LI Chao Wang**, aged 53, is a founder of the Group. He was appointed as an Executive Director of the Company on 17 August 1999 and has become the Chairman of the Board since 28 April 2000. In his current capacity, he would spearhead overall corporate development and strategic planning. Formerly until January 2010, he also acted as the Chief Executive Officer of the Group. Mr. LI has over 25 years of experience in the household paper industry and executive business management. Mr. LI currently is a member of Guangdong Political Consultative Committee, the vice president of the China Household Paper Association, vice president of the All-China Federation of Industry and Commerce Papermakers' Group and The Standing Committee of Guangdong federation of industry & commerce and the president of the Jiangmen City Federation of Industry and Commerce. Mr. LI graduated from the Guangdong Radio and Television University's business administration program. He is the director of the subsidiaries of the Group.

Pursuant to the service agreement, the appointment of Mr. LI is for an initial term of three years commencing from 1 January 2010 and his appointment would continue thereafter unless and until terminated by either party by giving at least three months notice in writing. Mr. LI is subject to retirement by rotation and re-election at annual general meetings in accordance with the Articles of Association. Mr. LI's existing remuneration is RMB2,167,100 per annum, which is commensurate with his duties and responsibilities held and is approved by the Board with reference to the prevailing market situation. Mr. LI is entitled to a management bonus to be determined by the Board and remuneration committee. The Board has distributed HK\$1,000,000 bonus to Mr. LI for the financial year ended 31 December 2011.

Mr. LI has not held directorship in other listed company during the past three years. He is a director and shareholder of Fu An International Company Limited, a controlling Shareholder of the Company, and the younger brother of Mr. LI Chao Bing, a member of the senior management. Save as disclosed above, he does not have other relationships with any directors, senior management, or other substantial or controlling Shareholder(s) of the Company for the purpose of the Listing Rules. There is no other matters relating to his re-election that need to be brought to the attention of the Shareholders and there is no other information that are required to be disclosed pursuant to Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules and there is not other matters which need to be brought to the attention of the Shareholders.

**Mr. DONG Yi Ping**, aged 49, was appointed as an Executive Director on 1 February 2000 and is the Group's Chief Technology Officer. Mr. DONG joined Vinda Paper (Guangdong) in 1991. Mr. DONG has over 20 years of experience in equipment operations and safety, quality control and research and development. Prior to joining the Group, he served in senior positions in two other paper manufacturing companies. Mr. DONG graduated from the paper manufacturing program of the Tianjin University of Science and Technology (previously the Tianjin College of Light Industry). He is the director of the subsidiaries of the Group.

Pursuant to the service agreement, the appointment of Mr. DONG is for an initial term of three years commencing from 1 January 2010 and his appointment would continue thereafter unless and until terminated by either party by giving at least three months notice in writing. Mr. DONG is subject to retirement by rotation and re-election at annual general meetings in accordance with the Articles of Association. Mr. DONG's existing remuneration is HK\$1,690,000 per annum, which is commensurate with his duties and responsibilities held and is approved by the Board with reference to the prevailing market situation. Mr. DONG is entitled to a management bonus to be determined by the Board and remuneration committee. The Board has distributed HK\$440,000 bonus to Mr. DONG for the financial year ended 31 December 2011.

Mr. DONG has not held directorship in other listed company during the past three years. He is a director and shareholder of Fu An International Company Limited, a controlling Shareholder of the Company. Save as disclosed above, he does not have other relationships with any directors, senior management, or other substantial or controlling Shareholder(s) of the Company for the purpose of the Listing Rules. There is no other

matters relating to his re-election that need to be brought to the attention of the Shareholders and there is no other information that are required to be disclosed pursuant to paragraphs 13.51(2)(h) to 13.51(2)(v) of the Listing Rules and there is no other matters which need to be brought to the attention of the Shareholders.

**Mr. Johann Christoph MICHALSKI**, aged 46, was appointed as a non-executive Director on 19 April 2008. Mr. MICHALSKI is the president of Svenska Cellulosa Aktiebolaget (“SCA”) Asia Pacific based in Shanghai, the PRC. SCA Asia Pacific is a business unit under the SCA Group, of which Mr. MICHALSKI has since 2007 served as senior vice president of Business Development and Strategic Planning. Previously he held a number of senior management positions in the New Zealand dairy group Fonterra as well as the global FMCG company, Unilever. He has over 16 years of experience in leading roles in business development and strategy, consumer marketing and innovation in the consumer goods industry. Mr. MICHALSKI has a master’s degree in economics from Kiel University, Germany.

Pursuant to the appointment letter, the appointment of Mr. MICHALSKI is for an initial term commencing on 19 April 2008 and ending on 31 December 2008 and may be terminated by either party by giving at least one month’s notice in writing. The appointment may be extended for such period as the Company and Mr. MICHALSKI may agree in writing. Mr. MICHALSKI is subject to retirement by rotation and re-election at annual general meeting in accordance with the Articles of Association. Mr. MICHALSKI’s remuneration is fixed at HK\$20,000 per annum, which is commensurate with his duties and

responsibilities as a non-executive Director and is approved by the Board with reference to the prevailing market situation. Mr. MICHALSKI will not be entitled to any bonus payment.

Mr. MICHALSKI has not held directorship in other listed company during the past three years. He has not previously held and is not holding any other position with the Company and its subsidiaries. Mr. MICHALSKI is the president of an operating unit of SCA and holds 8,850 shares of SCA, representing 0.001% of the capital of SCA, a substantial shareholder of the Company, as at 31 December 2011. Save as disclosed above, Mr. MICHALSKI does not have other relationships with any directors, senior management, or other substantial or controlling Shareholder(s) of the Company for the purpose of the Listing Rules. There is no other matters relating to his re-election that need to be brought to the attention of the Shareholders and there is no other information that are required to be disclosed pursuant to Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules and there is not other matters which need to be brought to the attention of the Shareholders. As at the Latest Practicable Date, Mr. MICHALSKI is not interested in any shares of the Company within the meaning of Part XV of the SFO.

**Mr. HUI Chin Tong, Godfrey**, aged 52, was appointed as an independent non-executive Director on 19 June 2007. Since the 1980's, Mr. HUI has established and managed several businesses in the PRC and is currently serving as executive director of Network CN Inc. Mr. HUI obtained his bachelor degree in business management from The Chinese University of Hong Kong and a master's degree in business management from the University of Hull in the United Kingdom.

Pursuant to the appointment letter, the appointment of Mr. HUI is for an initial term commencing on 19 June 2007 and ending on 31 December 2008 and may be terminated by either party by giving at least one month's notice in writing. The appointment may be extended for such period as the Company and Mr. HUI may agree in writing. Mr. HUI is subject to retirement by rotation and re-election at annual general meeting in accordance with the Articles of Association. Mr. HUI's remuneration is fixed at HK\$180,000 per annum, which is commensurate with his duties and responsibilities as an independent non-executive Director and is approved by the Board with reference to the prevailing market situation. Mr. HUI will not be entitled to any bonus payment.

Save as disclosed above, Mr. HUI has not held directorship in other listed company during the past three years. He has not previously held and is not holding any other position with the Company and its subsidiaries. He does not have other relationships with any directors, senior management, or other substantial or controlling Shareholder(s) of the Company for the purpose of the Listing Rules. There is no other matters relating to his re-election that need to be brought to the attention of the Shareholders and there is no other information that are required to be disclosed pursuant to Rules 13.51(2)(h) to 13.51(2)(v) of the Listing Rules and there is not other matters which need to be brought to the attention of the Shareholders. As at the Latest Practicable Date, Mr. HUI is not interested in any shares of the Company within the meaning of Part XV of the SFO.

This appendix serves as an explanatory statement, as required by the Listing Rules, to provide requisite information to Shareholders for their consideration of the proposed Repurchase Mandate.

### **REASONS FOR REPURCHASE MANDATE**

Whilst the Directors do not presently intend to repurchase any Shares, they believe that the flexibility afforded by the mandate granted to them if the ordinary resolution no. 6 set out in the notice of AGM is passed would be beneficial to the Company and its Shareholders. Trading conditions on the Stock Exchange have sometimes been volatile in recent years and if there are occasions in the future when Shares are being traded at a discount to their underlying value, the ability of the Company to repurchase Shares can be beneficial to those Shareholders who retain their investment in the Company since this may, depending on the circumstances, result in increases to the fully diluted net assets and/or earnings per Share and will only be made when the Directors believe that such a repurchase will benefit the Company and its Shareholders.

### **SHARE CAPITAL**

As at the Latest Practicable Date, the total issued share capital of the Company is 957,440,686 fully paid-up ordinary Shares of HK\$0.10 each.

The exercise of the Repurchase Mandate up to 10% limit would enable the Company to repurchase 95,744,068 Shares.

### **SOURCE OF FUNDS FOR REPURCHASES**

In repurchasing Shares, the Company may only apply funds entirely from the Company's available cash flow or working capital facilities, which will be funded legally available for such purpose in accordance with its Memorandum and Articles of Association and the Companies Ordinance. Such funds include but are not limited to the Company's profits available for distribution.

Whilst the Repurchase Mandate, if exercised in full, may have a material adverse impact on the working capital or gearing position of the Company, the Directors expect to exercise such mandate if and to such extent only as they are satisfied that the exercise thereof will not have such a material adverse impact.

### **UNDERTAKING**

The Directors have undertaken to the Stock Exchange to exercise the power of the Company to make purchases pursuant to Repurchase Mandate in accordance with the Listing Rules and the laws of the Cayman Islands and in accordance with the regulations set out in the Memorandum and Articles of Association of the Company.

None of the Directors nor, to the best of their knowledge having made all reasonable enquiries, any of their associates, presently intend to sell any Shares to the Company under the Repurchase Mandate in the event that the latter is granted by the Shareholders.

The Company has not been notified by any connected persons of the Company that they have a present intention to sell any Shares to the Company, or that they have undertaken not to sell any Shares held by them to the Company, in the event that Repurchase Mandate is granted by the Shareholders.

### TAKEOVERS CODE

If as a result of share repurchase by the Company, a Shareholder's proportionate interest in voting rights of the Company increases, such increase will be treated as an acquisition for the purpose of the Takeovers Code. completion of the subscription, in accordance with the terms of the ordinary resolution no. 6 to be proposed at the AGM, the aforesaid interests of Fu An International Company Limited and SCA Hygiene Holding AB in the issued share capital of the Company would be proportionally increased to approximately 33.71% and 18.85% respectively. The increase of Fu An International Company Limited's shareholding from approximately 30.34% to 33.71% will give rise to an obligation to make a mandatory offer under the Takeovers Code.
